The Board of Aldermen of the City of Springhill, Louisiana met in regular session in the Council Chambers at Springhill City Hall on Monday, July 14, 2025 at 5:00 P.M with Mayor W. Ray Huddleston presiding.

Mayor W. Ray Huddleston called the meeting to order.

Alderman Mike Whitlock opened the meeting with Prayer.

Mayor Huddleston asked to have the agenda amended to include an item of business for the Springhill Airport to authorize the Mayor to enter into a contract with LA DOTD for Phase II of the Runway Taxiway Project and adopt a Resolution.

Amie Poladian, speaking as a volunteer with the Main Street Board informed the public that she had ended her employment as the Main Street Manager effective July 5, 2025 as she has accepted the position as Director of the Webster Parish Convention and Tourism Commission effective July 8, 2025. The position for the Main Street Manager Position with the City of Springhill is now open and they are taking resumes at Springhill City Hall. Amie will be serving as a volunteer in the position in the interim to keep up with the current grants and activities until a new Main Street Manager is hired.

The next Farmers Market is Saturday, August 2, 2025. Also, the Downtown Road Maps Meeting was scheduled to be held the second week of August has now been postponed till November so that hopefully a new Main Street Manager will be present to be more involved in that. This will be conducted November 17–19. This is to develop a five-year downtown strategic plan.

The match project grant opens tomorrow for \$2,000 exterior façade improvements. The June winner was M & M Floral who will use the funds for new signage, awning and window repairs.

Amie congratulated Sharpe's for the new outside signage and renovations to their building. Good job Sharpe's!

Amie went on to say that she is excited about working with Webster Parish Tourism and helping promote tourism for all of Webster Parish.
